

Marketing agreement between:

The parties agree that the seller hereby instructs GWP to market and sell the game, listed in attachment A, as stipulated in the terms and conditions set out below

Terms and conditions

1. The seller herewith gives sole mandate to GWP for a period of 30 days from date of signature of this contract, to market and sell the game listed in attachment A.
2. The parties will establish a minimum price, for each animal or package as listed in attachment A, for which GWP may market and sell the animal. The agreed minimum price will be stipulated in Attachment B.

3. GWP's commission will be 3% of the sales price (before VAT) of the particular animal(s), on completion of successful sale.
4. The seller will be invoiced by GWP for the commission and the seller will be responsible for payment upon receiving the invoice.
5. In the case where the seller sells any or all of the animals listed in attachment A privately or through any other agency or auction during the 30 day sole mandate period, he will still be responsible for the payment of the 3% commission of the agreed upon minimum sales price as stipulated in attachment A to GWP
6. Any costs regarding the catch and loading process (inclusive but not limited to veterinary, helicopter, capture teams and insurance) will be for the account of the seller.
7. The risk will stay with the seller up to the successful loading of the animal(s) onto the agreed upon transportation after which the risk will move to the buyer.
8. The seller guarantees GWP that on date of signature of this agreement, the seller is in legal possession and ownership of the game listed in attachment A and that the game is in no way subjected to any, hypothecation, notary bond or any other bond or session of security of any kind.
9. The parties agree that GWP may assist the seller and may facilitate the process of acquisition of permits necessary for the translocation of the game. GWP will invoice the seller for any fees paid by GWP in regard to such permits.
10. This agreement represents the whole of the agreement between the parties and no alterations or cancelations will be binding unless it has been written and signed by both parties.
11. Any notices regarding this contract will be written and will be delivered to all parties by email
12. The parties agree that GWP's representatives or agents may have interest in the game industry in their private capacity.
